I hereby undertake to participate in the modules of the planned language course **on a regular basis**. My goal is to improve my German language skills so that I can start work as soon as possible or commence vocational training or a course of studies.

As a rule, failure to attend at least 50% of a module will invalidate the entitlement to continue participating in the language course. Continued participation may be possible in justified individual cases.

The cost of teaching materials is to be borne by myself, as are any travel expenses.

If the distance between the place of residence and the course venue is more than 3 km and there is an actual attendance of more than 50% per module (100 lessons), a lump sum of € 50.00 may be reimbursed after completion of each module, provided that the travel expenses incurred exceed € 70.90.

The difference between the travel costs incurred and the lump sum shall be borne by the course participant. The minimum own contribution is € 20.90 per module of 100 lessons.

Payment shall be made upon presentation of the proven travel costs by the language course provider.

I hereby undertake to fully observe and follow the rules of conduct laid down for the courses by the language course providers. I shall be **immediately** excluded from the language programme in the event of non-compliance.

If the student drops out of the course, then it will **not** be possible to participate again at a later date!

I have understood the points set out above and, by affixing my signature, undertake to attend a language course in accordance with the German for Refugees Administrative Regulation.

I have been informed that refusal to grant this consent will not have any detrimental legal consequences for me.

1.3 Purposes of the processing and legal basis

An administrative regulation course based on the German for Refugees Administrative Regulation of the Federal State of Baden-Württemberg is designed to enable you to improve your German language skills. In order to coordinate, plan and settle the courses with the Federal State of Baden-Württemberg, personal data concerning participation in the language course, as well as data concerning the development of language skills following participation in the language course, are collected. Following your consent, your data may be processed by the employees responsible for the course organisation at the Rhine-Neckar District Administration exclusively for the specified purpose. This also includes the reciprocal transmission of data between language course providers, the Rhine-Neckar Region District Administration, the municipality of your place of residence, the Employment Agency as well a the Ministry for Social Affairs and Integration of the Federal State of Baden-Württemberg as well as the Federal Office for Migration and Refugees.

The transmission of data is necessary for the coordination and efficient planning of your language course and for further qualification.

The data needs to be recorded in order to enable the German for Refugees Administrative Regulation (of 11 May 2016 - File Ref.: 3-5913/3-3-) to be implemented.





1.4 Recipients or categories of recipients, if the personal data is regularly forwarded.

The data is recorded by the District Social Services Office or Integration Management Office of the municipality in which you are resident, and is forwarded to the Rhine-Neckar Region District Administration. This data is also exchanged between the language course providers, the District Administration, your Social Services Office and the German Employment Agency. In addition, the respective language course provider records data on your attendance rate and passes this to the other bodies.

2. Information needed for fair and transparent processing

2.1 Duration of the data storage or criteria used to determine the duration

In general terms, you data will be saved for as long as is necessary in accordance with the abovementioned legal purpose. After 10 years, the datasets will be reviewed and, if necessary, data that is no longer used or is inactive will be deleted.

2.2 General rights of data subjects

The data subject has the following rights set out in the Articles:

- the right to information pursuant to Art. 15 GDPR,
- the right to correction pursuant to Art. 16 GDPR,
- the right to deletion pursuant to Art. 17 GDPR,
- the right to restrict processing pursuant to Art. 18 GDPR,
- the right to data portability pursuant to Art. 20 GDPR,
- the right to object pursuant to Art. 21 GDPR.
- 2.3 Right to revoke issued data processing consent pursuant to Art. 6 Para. 1a or Art. 9 Para. 2a EU GDPR for the future
